Letters of Credit payment terms will only be accepted for order values equal or greater than [USD\\$20,000](#) unless otherwise agreed upon in writing by DynamicSignals LLC.

Each order having Letter of Credit payment terms must include an additional charge of 2% of order value (*minimum US\$400.<sup>00</sup>*) up to a maximum of US\$1,000.<sup>00</sup> that will need to be **included in the LC Amount** to cover the administrative costs associated with processing this method of payment.

- To be shipped on a FREIGHT COLLECT basis by AIR. *If no forwarded advised by Applicant, shipment will be dispatched using Beneficiary's choice of Freight Forwarder/Transport Company.*
- Insurance charges (if requested) shall be to applicant's account for 100% of shipment value.
- Shipment from any North American Airport to a *named Int'l Airport:* \_\_\_\_\_
- Partial Drawings/Shipment: ALLOWED
- Transshipment: ALLOWED (*specifically due to lack of direct overseas flights from Canada*)
- **ALL** Letter of Credit costs including issuing bank charges, advising bank charges, confirmation fees, amendment charges, reimbursement charges etc., both in Applicant's country and the United States are for the **APPLICANT**.
- Terms of Drafts: **100% payable "At Sight"** upon presentation of shipping documents evidencing shipment from Canada.
- The Letter of Credit must allow a minimum of 21 days for presentation of documents to negotiating bank.
- The Letter of Credit must allow for 'Cable/EFT' reimbursement through a named United States Bank, preferably the advising bank; M&I Marshall and Ilsley Bank.
- The Letter of Credit is to be advised & confirmed through: M&I MARSHALL AND ILSLEY BANK

If the Letter of Credit is not issued according to the instructions listed above, DynamicSignals will refuse to accept the order. Any amendment charges that result from these discrepancies will be on Buyer's account.
